



The CUFA Fijian Leadership Challenge is an exciting physical, intellectual, emotional and cultural challenge that will see Challengers stretched beyond their comfort zones and into the experience of a lifetime.

There are four phases to the CUFA Fijian Leadership Challenge program

1. Selection Phase

Application: Fill out your details on the application form and return to CUFA with a deposit of \$500.00. Places are limited so to ensure participation, **registrations need to be accompanied by a deposit of \$500.00 that is non-refundable.**

2. Preparation Phase

Cost and Fundraising: Sponsoring workplaces or Challengers pay **AUD \$4300.00** for the CUFA Fijian Leadership Challenge and **fundraise AUD \$3,300.00**, which will be directly used for CUFA's Pacific project work. A deposit of AUD \$500.00 needs to accompany this form prior to any fundraising activity and the balance of \$3800.00 is to be paid by 24/02/2011. Fundraising totals need to reach \$3300.00 one week prior to departure.

The CUFA Fijian Leadership Challenge cost of \$4,300.00 includes:

- International airfares from Sydney to Nadi/Kadavu
- All accommodation in twin share
- Tamarillo professional kayaking leader and support team
- Use of a quality double kayak
- English speaking local guides
- All meals as per the itinerary
- Private support boat to carry all luggage and passengers if a participant is unable to kayak
- All on the ground transport in Fiji, visits to village savings banks
- Entrance to Fiji Museum

Exclusions:

- Passport
- Travel insurance
- Any personal expenses or purchases Challengers wish to make
- Travel to Teambuilding workshop in Sydney during March-see preparation workshop below.

Essential: Challengers need to ensure they have a valid passport for the intended time of travel. Full travel insurance is compulsory, which **must include medical travel evacuation** from Fiji

Preparation Workshop: Challengers will be required to attend a Teambuilding workshop in Sydney to learn more about the Fijian Challenge and to meet the other Challengers.

3. Overseas Project Phase

In-country orientation: Upon arrival Challengers will attend an orientation program covering topics such as local history, geography, cultural and development issues, participant roles, policies and procedures, health and safety systems.

Physical Leadership Challenge: Challengers kayak around Fijian islands and visit villages and provinces for 7 days, which Challengers are expected to sufficiently train for beforehand. See itinerary for full details on kayaking component. Kayaking is a wonderfully unique and intimate way of engaging with the Fijian people and of seeing

communities.

Project Challenge: Challengers are required to fundraise a minimum of AUD \$3,300.00 that will be assigned to CUFA's International Project Fund, and then used to fund CUFA's Pacific Programs. Fundraising is an important part of the Leadership Challenge so that Challengers can see where the money that they have raised goes and the impact that it has on people's lives. All donations are 100% tax deductible (for Australian Challengers only).

In-country Project Work: Challengers will be learning about the Oceanic Confederation of Credit Unions, an industry body that organises, supports and represents the South Pacific leagues and federations-linking all its members through a common bond of cooperation and development. Challengers will also visit developing credit unions and assist in training sessions that will greatly benefit the Pacific movement.

4. Return Phase

- **Ongoing community service:** Upon return, Challengers will be inspired to engage with their own local Credit Union Community Programs and Community Partners. CUFA encourages ongoing community engagement through volunteering within your local credit union community.

Report to your sponsoring workplace (only if you are sponsored by your workplace) When Challengers return they will be required to provide a report to their CEO/Board and to CUFA, including the personal and professional outcomes gained from participating in the Fijian Leadership Challenge.
